

REQUEST FOR PROPOSAL (RFP)

National Energy Corporation of Trinidad and Tobago Limited (NEC) invites proposals from interested and qualified firms for "Design Build for Port Facility at Galeota PHASE II".

INVITATION DOCUMENTS

PRE-QUALIFICATION OF BIDDERS

Prequalification of Tenders will be made in accordance with NEC's Prequalification criteria and NEC will consider:

- Relevant Work Experience (previous and current)
- Relevant Port Design and Construction Experience
- · Personal Resources
- · Financial Position
- · Equipment Resources, and
- · Environment and Safety

This procurement process is not intended to create and shall not create a formal legally binding process and shall instead be governed by law applicable to direct commercial negotiations. For greater clarity and without limitation:

- The RFP shall not give rise to any "Contract A" based tendering law duties or any other legal obligations arising out of any process contract or collateral contract; and
- Neither the Tenderer nor NEC shall have the right to make any breach of Contract, tort or any other claims against the other with respect to the award of a contract or failure to honour a response to the RFP.
